Margate Inner-City Transit

The City of Margate and Broward County Transit (BCT) are providing this service to increase the number of destinations within the city limits that can be reached through public transit.

Margate Inner-City Transit is designed to operate in conjunction with connections to BCT routes 18, 441 Breeze, 42, 60, 62, and connects to Coconut Creek Community Bus.

There is a 75¢ per trip charge for using MIT. Riders making the connection to BCT buses must pay the appropriate fares. No transfers from BCT buses will be accepted on MIT.

Holidays

There is no service on the following holidays observed by Margate Inner-City Transit: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day and Christmas Day.

Regular service is in effect on the following days: Martin Luther King, Jr. Day, Veterans Day, the day after Thanksgiving and Christmas Eve.

Hours of Operation

7:20 am - 4:20 pm**

Service operates as close to schedule as possible, although traffic conditions may cause MIT to arrive slightly early or late. Please allow yourself enough time when traveling.

These routes will not operate when a hurricane warning has been issued.

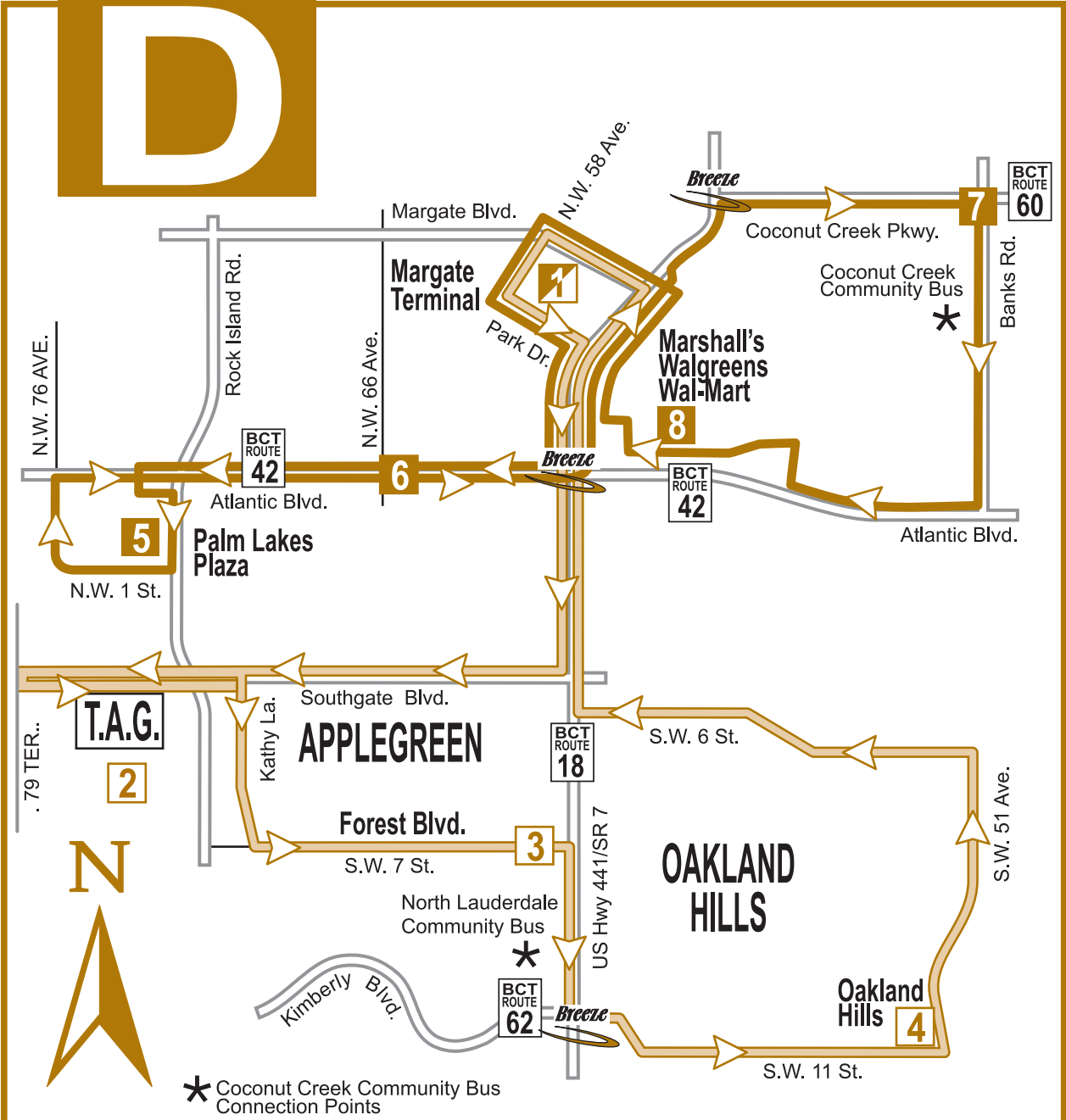
