



Downtown Courthouse Loop

The City of Fort Lauderdale and Broward County Transit (BCT) are providing this Sun Trolley service to increase the number of destinations that can be reached through public transit within the Fort Lauderdale and surrounding communities.

The Downtown Courthouse Loop provides a continuous loop within downtown Fort Lauderdale, connecting the BCT Central Terminal, City Hall, County Governmental Center and the Broward County Courthouse.

This service offers convenient connections to a number of residential, retail, recreational and commercial locations, as well as the City's parking garages along the route.

The City of Fort Lauderdale Sun Trolley is air-conditioned and wheelchair accessible and also has bike racks. Riders making connections to BCT routes are expected to pay the exact fares.

Fares

The fare for Downtown Courthouse Loop is 50¢ per trip. Drivers are permitted to collect exact fares only. No pennies accepted. Drivers cannot make change, issue BCT transfers or accept BCT passes.

The Sun Trolley will operate as close to schedule as possible. Unforeseen conditions may cause the community bus to arrive earlier or later. Please allow yourself enough time when using the service.

The Sun Trolley will not operate when a hurricane warning has been issued.

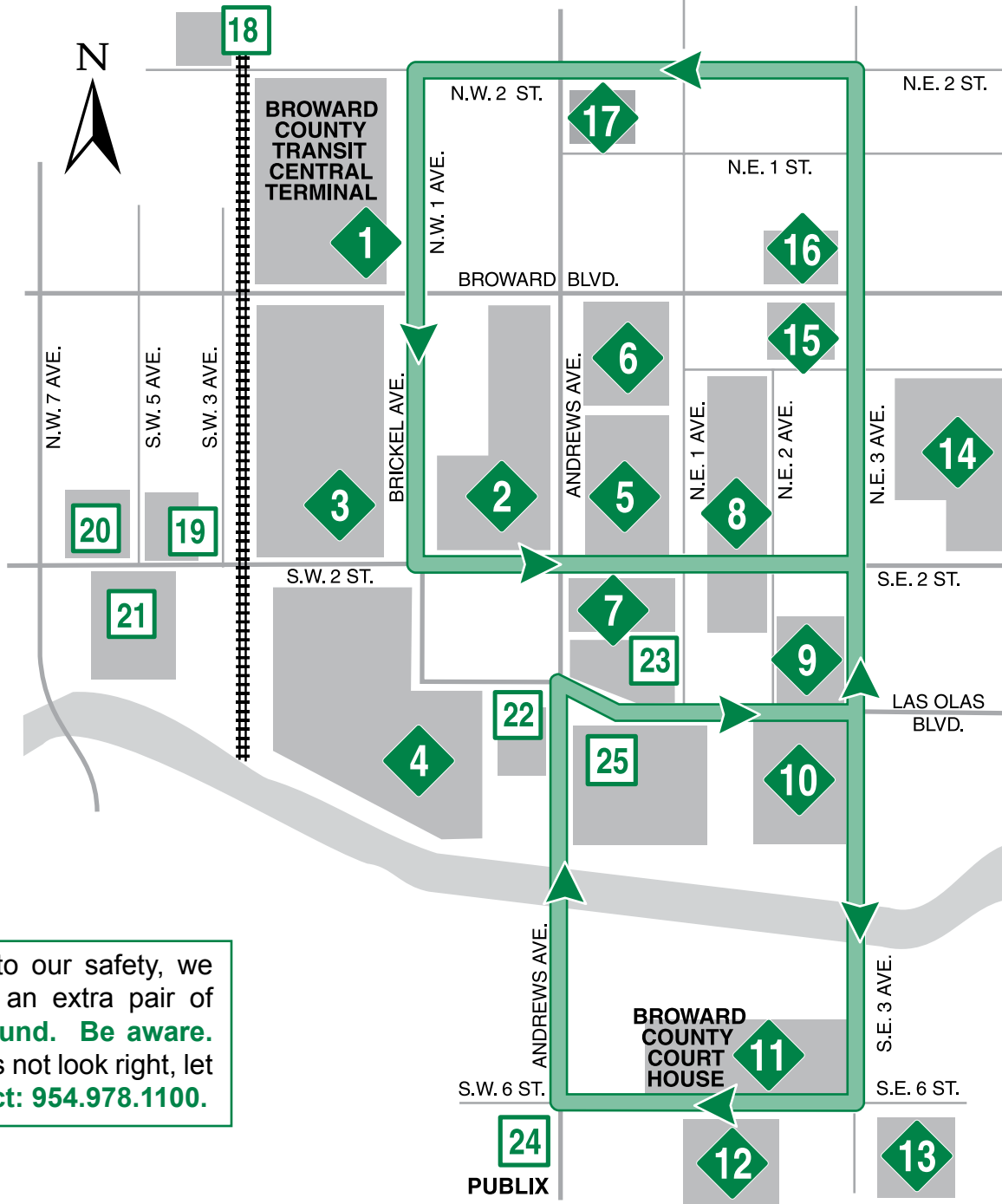
Community Trolley Service Route and Timetable
