CALL TO ORDER

1. MOTION TO ADOPT Resolution 95-44 to vacate and abandon anchor and conductor easements and setback lines, lying and being in Broward County, Florida, located on the south side of Griffin Road and on the east side of SW 35 Avenue in the City of Hollywood. Petitioner: VST/VMIF Oakridge Partnership (Berry & Calvin - Agent) 1-V-95.

ACTION: (B-026) Approved.

2. MOTION TO ADOPT Resolution 95-45 to vacate and abandon road right-of-way and utility easement, lying and being in Broward County, Florida, located between SW 160 Avenue and SW 166 Avenue, north of SW 66 Street in the Town of Davie. Petitioner: Engle Homes/Broward, Inc. (Consulting Engineering - Agent) 34-V-94.

ACTION: (B-40) Approved.

3. MOTION TO CONSIDER enactment of an ordinance 95-1, the substance of which is as follows:

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BROWARD COUNTY, FLORIDA, AMENDING SECTIONS 2-221, 23-20.9, AND 23-20.16(f) OF THE BROWARD COUNTY CODE OF ORDINANCES, WHICH RELATE TO ADMINISTRATIVE HEARING OFFICER REVIEW OF PARKING CITATIONS; PROVIDING FOR THE CREATION OF A FEE FOR THE COSTS OF AN ADMINISTRATIVE HEARING WHERE THE CITATION IS UPHeld BY THE HEARING OFFICER; PROVIDING FOR THE CREATION OF A FEE FOR THE GRANTING OF A POSTPONEMENT OR RESETTING OF A HEARING; PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN CODE; AND PROVIDING FOR AN EFFECTIVE DATE.
